

#### **USER INSTRUCTIONS**

Assemble visor as shown overleaf, in exact order of steps 1 to 4.

#### For- Challis Ag+ 3110/01:

Place headband and visor complete over face, adjust cord & toggle until comfortable and secure. The toggle will lock the cord as desired.

#### For- Challis Ag+ 3110/02:

The headband is indented with a series of equidistant slots. Place one of the end slots on to the headband attachment. Pull the elasticated band until the headband is comfortable and secure and place the nearest available slot over the other headband attachment.

#### For- Challis Ag+ 3110/01 & Challis Ag+ 3110/02:

The visor is affixed to the headband by snap fittings, the visor is easily removed and replaced by use of these fittings.
